The Ontario Hockey Federation (OHF) has principally approved Under-10 to Under-18 player evaluations for the 2023-24 season to be conducted during the spring. Associated Regulations will be amended/adopted by the OHF during its Semi-Annual meeting of the Members (February 25). Those Regulations will align with the below requirements.

Lastly, we wish to express our gratitude to the members of Hockey Canada and the Hockey Canada Board of Directors for their support and understanding in allowing the OHF to implement spring evaluations while maintaining the core philosophies of the player pathways.

Spring player evaluations are subject to the following requirements:

<u>Preparation Phase</u>: all players have access to a minimum of four practices/skill sessions prior to formal player evaluations.

- Eligible to begin March 2.
- Only players no longer engaged in regular season, or playoffs, or playdowns, or similar (as determined by the Member) permitted to participate.
- May not be utilized to conduct formal or informal player evaluations.
- 2023-24 coaches not permitted to deliver preparation phase ice sessions.
- May not be implemented per Division.
- Recommend implementing ice sessions for multiple [age] Categories (ex. U13, U14, U15 grouped together).
- Ice sessions must be focused on individual skill development.
- The OHF will make practice plans available to associations by January 30, 2022.



AAA Player Evaluations: must be delivered April 24 – 30.

- Does not apply to Under-18 AAA which will adhere to Playing Regulation K.

AA Player Evaluations (within LOR): must be delivered May 1 – 7.

A Player Evaluations (within LOR): must be delivered May 8 – 14.

AA & Below Player Evaluations (outside LOR): associations upon consultation with their affiliated Member permitted to deliver spring or fall evaluations.

- If spring evaluations are implemented, must begin May 1 or later.
- If fall evaluations are implemented, preparation phase required to be implemented in the fall.
